SHP Master Facility Plan Update

James Grube, Interim Superintendent provided a brief outline of the data collected by Cropper GIS as part of the enrollment study. Cruiser Connect Summer Learning Opportunity and Transportation Update

Dr. Jana Alig presented an update on Cruiser Connect Summer Learning. Dr. Alig reminded the Board the program offered additional learning to students and focused on reducing the learning loss which occurred as a result of the pandemic. The program was successful in reducing the Summer slide for students who attended last year. The program promises to provide the same results for students enrolled for the current year; however, attendance is less than expected.

Efforts are being made to determine why student participation is not what was expected. Preliminary thoughts for the reduced participation include bussing, child care following the halfday program, and families returning to their pre-pandemic Summer lifestyles.

Mr. Chris Reed provided an update on the transition to the new student transportation company, Commercial Bus Services (CBS). Mr. Reed stated while the lack of historical routing data is the biggest obstacle to overcome. He stated the routing software has been purchased and that determining the routes to accommodate students requiring transport is the current task. CBS remains positive that they will be able to transport our students beginning the first day of school. Mr. Reed advised the Board that CBS is having success securing drivers to fill each route, which is reassuring. Mr. Reed will provide additional updates leading up to the first day of school and thereafter.

Discussion of House Bill 99

Mr. Grube opened the discussion surrounding House Bill 99. The Board unanimously agreed it is in the best interest of students, staff, and the Groveport community to oppose this legislation. <u>Attachment</u>
