## Presentation – Levy Workshop by Bricker & Eckler Attachment

Becky Princehorn shared her history with the district, having worked with Groveport Madison since 1981. She then discussed a pivotal moment in the district's past, specifically the passing of a 13-mil levy in 1991, which helped the district overcome a fiscal emergency and avoid a potential merger with Columbus City Schools. Paul Rutter reviewed different options for levies, specifically emphasizing the importance of a neutral, informational, and verifiable approach. He also noted that the Board President should be the one to discuss any potential cuts and that a higher functioning levy campaign committee would be necessary to present information to civic groups in a neutral, informative, and verifiable way. Board President Dowdell-Burger emphasized the need to have the levy campaign committee meet outside of school buildings and to present information in a way that is not overly emotional. She also noted that any committee members who take time off work to participate should document it as paid leave or vacation time.
