Facilities Update

Director of Business, Chris Reed provided a facility update to the board. He highlighted that Primary One Health Center is progressing as planned. Mr. Reed also stated that item 8 on the Superintendent Agenda is not the actual GMP, but just authorization from the Board to allow the Superintendent and Treasurer to approve the GMP once it is ready as opposed to having to wait for a scheduled board meeting to approve the GMP.

Human Resources Update

- Director of Human Resources, Matt Cygnor and Director of Business, Chris Reed shared the updated list of available positions. Mr. Cygnor confirmed first job fair was last week at Otterbein University. Upcoming job fairs include Cincinnati, Ohio University, Ohio State, and an event in Akron. LaToya Dowdell-Burger questioned the process of a student teacher becoming a permanent staff member. Mr. Cygnor confirmed that student teachers are a great recruiting source and that several student teachers have accepted permanent positions at our district.
- Mr. Cygnor also confirmed that he provided the expulsion data requested by board member Libby Gray. She confirmed it is what she expected and appreciated it.
