### **Transportation Update**

- Chris Reed presented the Board and those in attendance a Transportation Update. Mr. Reed acknowledged that the start has not been great and the unhappiness is warranted. However, there have been improvements and the situation will continue to improve each day. Mr. Reed thanked OSP for completing inspections as busses arrive and all involved in getting titles transferred. Mr. Reed noted that there have been some issues with inconsistent technology and cameras not working, which will be resolved in the coming week. Mr. Reed conveyed confidence that the 56 purchased busses will be enough to sufficiently service the district. Mr. Reed explained the process of relaying delay information from bus drivers to parents.
- > Terry Thomas, CBS, was also invited to answer questions. Terry noted that there are 40 CDL drivers, with another 30 in training. Mr. Thomas explained the hiring process for

bus drivers and noted that there is a barrage of applicants they are working on interviewing. He expressed that the hiring process is geared toward building a long-lasting workforce. Mr. Thomas also explained the route tracking technology used in the buses in accordance with Board policy.

➤ James Grube, Superintendent, addressed the Board and those attending in response to questions. Mr. Grube explained that there was discussion over potentially delaying the start of the school year, but the decision was made to continue as planned. Mr. Grube noted the start of the school year is never smooth. Mr. Grube confirmed that there are no radios on the buses, however, bus drivers are utilizing hand held radios until this can be rectified. Mr. Grube also confirmed that Zonar tablets are expected to be received within the next few days.
